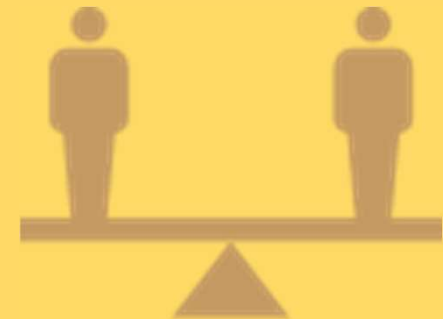


ALDA'S NETWORK

A MEMBERSHIP-BASED ORGANISATION



ALDA is funded through **project funding** from the European Commission, the Council of Europe, and other public and private donors, as well as **membership fees**.

Today ALDA is a **membership-based organisation** gathering more than **350 members** coming from more than 45 countries of the enlarged Europe area.

The members are mostly composed in a balanced way by Local Authorities (Municipalities, Regional Authorities and Associations of Local Authorities) and Civil Society Organisations, and they represent the real added value in the implementation of ALDA's programme of activities. Through its members ALDA has a vast coverage of countries' representativeness and they have the opportunity to refer to a group of actors sharing the same values, commitment and best practices.

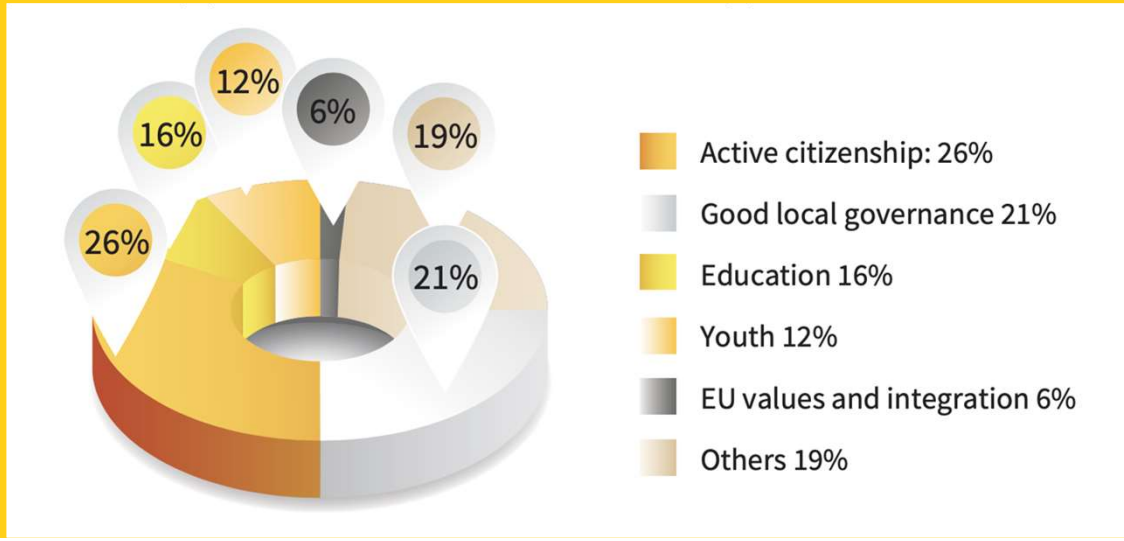
PROJECT PARTNERS' COMPOSITION

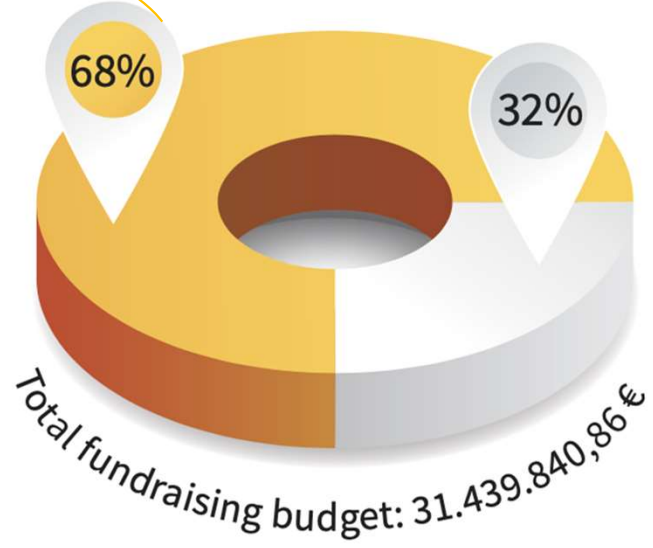

To turn ideas and plans into reality, ALDA advocates for them to influence **policy-makers** and **public opinion** in adopting like-minded policy or views

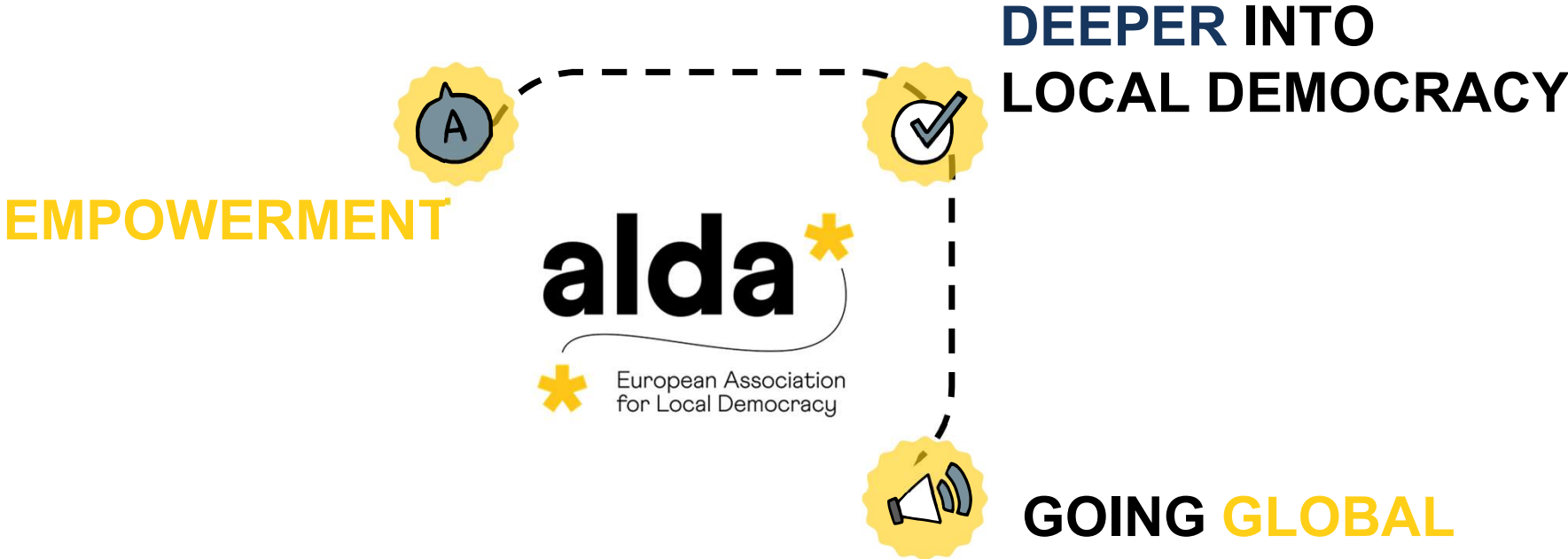
